Virtual events in Latvia and Slovakia: highlighting ICCCS project outcomes

Lyon, France, 8 January 2024 – To mark the end of the Improving Cancer Care Coordination and Screening in Latvia and Slovakia (ICCCS) project, the International Agency for Research on Cancer (IARC) and partners are co-organizing two virtual events to showcase the project outcomes. These events will specifically focus on Latvia and Slovakia and will bring together experts in cancer screening and cancer registration, oncologists, policy-makers, patient advocates, and researchers.

Presenting key recommendations

Experts will present recommendations for strengthening cancer control in the areas of cancer registration, cancer screening, comprehensive cancer-care networks, and communication for raising awareness about the importance of cancer screening.

"The recommendations are a valuable resource for authorities and stakeholders involved in cancer care, offering strategic insights to foster a more effective and coordinated approach towards cancer prevention and treatment", says André Carvalho, scientist at IARC and principal investigator of the project.

These publicly accessible virtual events are scheduled for 10 January 2024 at 14:00 CET (15:00 Latvian time) in Latvia and on 11 January 2024 at 14:00 CET in Slovakia.

The ICCCS project

The ICCCS project is a unique partnership between IARC, the Directorate-General for Structural Reform Support of the European Commission, and the ministries of health of Latvia and Slovakia. The project is funded by the European Union via the Technical Support Instrument. Launched in 2022, the project is aligned with Europe's Beating Cancer Plan¹, with a focus on developing strategic plans and roadmaps in collaboration with national partners to help reduce cancer mortality in Latvia and Slovakia. The aim was to optimize existing screening programmes, develop comprehensive cancer-care infrastructure, and strengthen cancer registries by building capacity for population-based cancer registration and preparing an efficient communication plan.

Europe's Beating Cancer Plan

The goal of Europe's Beating Cancer Plan is for each country to ensure that more than 90% of eligible populations have access to quality-assured screening for cancers of the breast, cervix, and colorectum, and that more than 90% of patients with cancer have access to comprehensive cancer centres. In addition, Europe's Beating Cancer Plan stresses that each country should strengthen cancer registration to enable the tracking of trends and national cancer burdens.

"In Latvia we are still facing substantial problems with cancer registration and cancer screening, and the major oncology hospital has just initiated the accreditation process of a Cancer Centre", say Mārcis Leja and Rolands Lappuķe, local coordinators of the ICCCS project in Latvia, "However, this project has marked important changes to cancer care in the country. Internationally accepted criteria have been implementing to the process of re-designing cancer registration, a political decision has been made in respect to the screening organization, and the objective to proceed to a Comprehensive Cancer Centre accreditation has been included to the future strategy. We expect that the results of the project and communication between local and international partners that has been initiated during the project will help save many in Latvia."

"Despite some progress, Slovakia continues to experience high burden of cancer, inequalities in access to cancer care, including cancer screenings and lack of reliable information about cancer prevention. Our participation in ICCCS project helps us address cancer screening coordination, communication and cancer registration, and take actions based on the recommendations we received", explains Daniela Kállayová, Senior Public Health Officer at the Ministry of Health of the Slovak Republic.
